Resolved to open the meeting for public participation
A member of the public informed that they had attended the Boreas/Vanguard hearings in Norwich. They pointed out the suggested “ring main” option for channelling the electricity from the windfarm around the sea rather than digging up areas of North Norfolk. It was expressed that the “ring main” idea would probably delay the application for 3-4 years. It may then lead to the project NOT proceeding as DC. Everyone had fought so hard for DC and anything else was not acceptable. The implications of any alterations would be significant and unacceptable.

Council Tax Precepts New Financial Year 2019/20

For Band D Council Tax payers the County Council precept will rise by nearly £40, the Police Authority precept will rise by £24 and the District Council precept rise is recommended to be just under £5. These rises reflect Government policy in recent years to reduce central government grants to local councils and instead expect them to raise more funds at a local level to fund council services. In spite of these rises all three authorities are currently forecasting varying levels of financial deficits in future years.

Sandscaping Project: The required funding for the extension of the scheme from the Gas Terminal to the villages of Bacton and Walcott has been secured. Planning and Marine consents for the project were given in December. Following a tender process a contractor has been appointed. The District Council is the overall co-ordinator for the project. Work is scheduled to begin in April and will continue throughout the summer.

Vattenfall Windfarm (Vanguard) Planning Application. In recent weeks the public hearings in front of Planning Inspectors have been taking place in Norwich. I attended a public participation session on February 6th. The main issues for parishes like Witton & Ridlington is the construction timetable for the ducts/laying of cable, access by vehicles to the construction path and the location of building storage depots. Happisburgh Parish Council have been frequent attenders given their concerns over the landfall site to the south of the village. There is also a Better Broadband for East Ruston community group which is in discussion with Vattenfall about using their cable duct for fibre optic cable to improve broadband connectivity to rural communities. They wish to build and run a community owned 'full fibre to the home' service. They are looking for support from adjoining Parish Councils.
